ADDITIONALLY, ALL BOARD MEMBERS AND STAFF ARE NOW REQUIRED TO REVIEW AND SIGN THE IAC CODE OF ETHICS AT THE BEGINNING OF EACH NEW TERM AND ON AN ANNUAL BASIS. A COMPREHENSIVE CONFLICT OF INTEREST POLICY WAS ALSO ADDED, APPLYING TO ANY BOARD MEMBER WITH A DIRECT OR INDIRECT FINANCIAL INTEREST, AND INCLUDES DISCLOSURE REQUIREMENTS AND PROCEDURES FOR ADDRESSING CONFLICTS. LASTLY, THE BYLAWS WERE AMENDED TO INCLUDE A REPRESENTATIVE FROM IAC'S YOUTH ADVISORY BOARD AS A VOTING MEMBER, INCREASING THE TOTAL NUMBER OF ALLOWABLE BOARD MEMBERS TO 13.

THE DULY APPOINTED DELEGATES ATTENDING THE CAUCUS WILL NOMINATE AND SECOND CANDIDATES FOR CONSIDERATION.

THE BOARD, EXCLUDING THE INTERESTED PERSON, DETERMINES WHETHER A CONFLICT EXISTS AND EVALUATES ALTERNATIVES TO THE PROPOSED ARRANGEMENT TO ENSURE THE ORGANIZATION'S BEST INTERESTS ARE SERVED.

IF IT IS DETERMINED THAT A MEMBER HAS FAILED TO DISCLOSE ACTUAL OR POSSIBLE CONFLICT, THE BOARD WILL TAKE APPROPRIATE DISCIPLINARY AND CORRECTIVE ACTION.
